Proposed Operations:

1. Set CIBP @ 10,450'. (Top of perfs @ 10,519'). Dump 35' cmt on top of plug.
2. Pull casing. (Top of cmt @ 9740'). Load hole w/9.5 ppg brine w/25 #/bbl salt gel.
3. Set 100' cmt plug 1/2 in and 1/2 out of 5-1/2" csg stub. Tag plug.
4. Set 100' cmt plug across Glorietta. Top of Glorietta @ 6056'.
5. Set 100' cmt plug 1/2 in and 1/2 out of 8-5/8" csg, set @ 4500'.
6. Set 100' cmt plug inside of 8-5/8" csg from 1750' to 1850'. Top of Anhydrite @ 1856'.
7. Set 10 sx cmt in top of 8-5/8" w/marker installed.

Will call w/proposed date of plugging operations.
