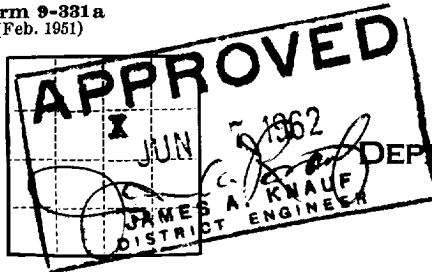

DETAILS OF WORK

U. S. GEOLOGICAL SURVEY

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casing; indicate mudding jobs, cementing points, and all other important proposed work)

It is our intention to drill a well at the above location to an approximate depth of 4350 to attempt a completion in the Grayburg-San Andres horizon. All casing points will be cemented in accordance with approved methods of the USGS, and any special requirements will be complied with.

It is planned to use the following casing pattern: 11" hole, 7 5/8" casing to be set at 1050' and cemented with 400 sacks. Cement is to circulate. 6 3/4" hole, 4 1/2" casing to be set at 4025' and cemented with 275 sacks. Cement is to return to 2000'.

Approval to produce this well upon completion is also requested.

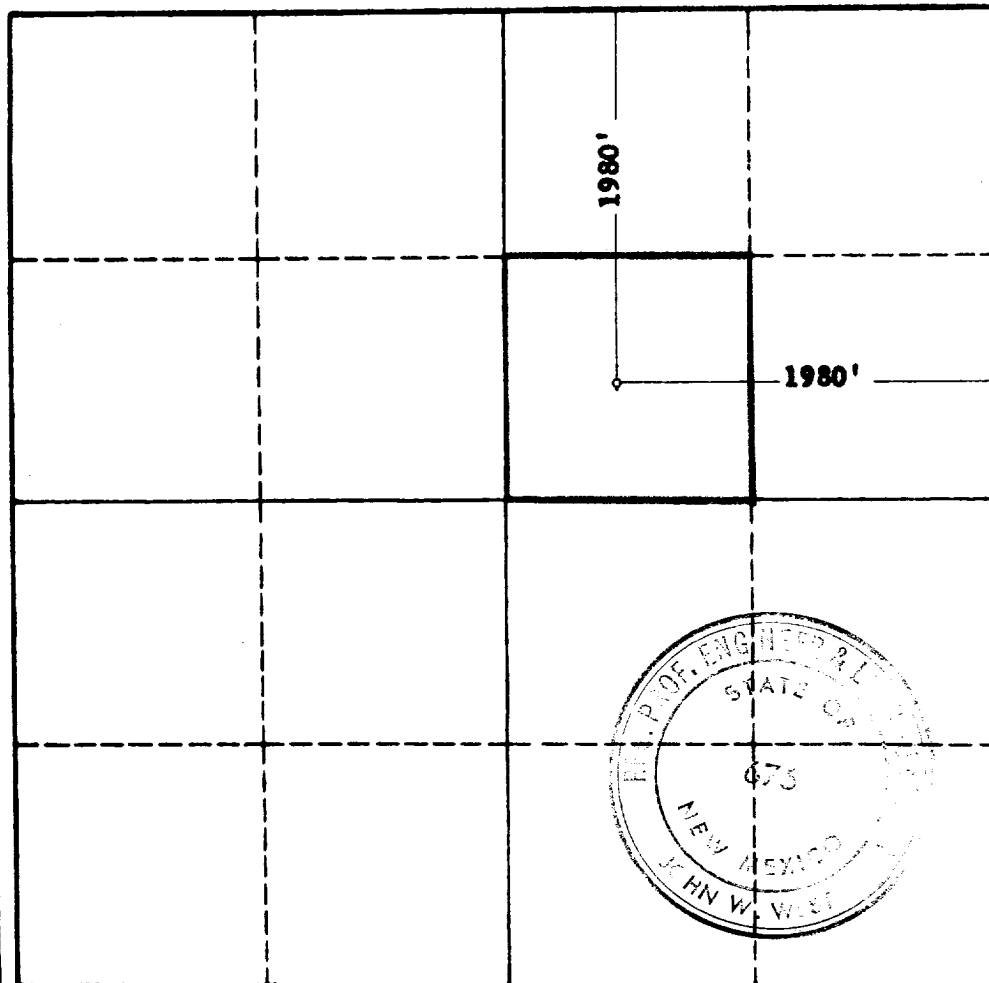
