1. Cleaned out junk tubing and open hole to 5640' (T. D. 5690')
2. Set Hookwall Packer at 4173'. Tested casing (9 5/8") to 500# for 30". Held OK
3. Set Baker Model D production packer at 4107' with wireline
4. Ran 3 1/2" plastic coated tubing and set in packer
5. Loaded annulus between 3 1/2" tubing and 9 5/8" casing with treated water
6. Acidized open hole with 15,000 gallons acid from 4274' to 5640'
7. Resumed saltwater disposal
