FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

PROPOSED OPERATION:

1. Kill well, pull tubing.
2. Perforate Wolfcamp interval 10,469' - 10,475' w/4 jet shots per foot.
3. Run tubing w/packer set at 10,487'.
4. Wash perforations above packer w/250 gallons MCA, then inject 250 gallons MCA.
5. Swab test.
6. If necessary, acidize w/1500 gallons 15% NEA.
7. Contingent on test results, place upper and/or lower zone on production.
