STATE "Q" LEASE WELLS #1 & #2 S/2 SE/4 Section 36-16S-36E
STATE "R" LEASE WELLS #1 & #2 E/2 SW/4 & NW/4 Section 36-16S-36E
STATE "S" LEASE WELL #1 SE/4 SE/4 Section 35-16S-36E

Above leases have same basic royalty to State of New Mexico. In order to reduce number tanks being used and eliminate necessity of installing separate treating system on each lease as now constituted, it is proposed to consolidate all leases into one, set a central tank battery and treating system and produce the wells into the central system. Manifold header will be installed so that individual well tests can be made at will, without having to shut all other wells in during test. All wells involved are now producing the top allowable assigned. This change will make possible the salvage of several tanks and material for use in other development work and thereby conserve vital war material. This notice supercedes previous application approved December 29, 1943 by Mr. Roy Yarbrough, Oil & Gas Inspector, Hobbs, N.M.
