Set 4689' of 5 1/2" liner at 9326, Top of liner at 4637', cemented with 100 sacks 4% gel, 200 sacks neat. Squeezed top liner at 4637' with 150 sacks 4% gel, 150 sacks neat w/1500# pressure. Top of cement at 6460. W.O.C. 24 hours. Did not circulate. Tested top of liner at 4637' with 2000# pressure for 30 minutes before and after drilling plug - no break.
