Spudded 4-16-54 - TD 320 - Set 13 3/8" OD Spiral weld casing @ 319 and cemented with 350 sacks of cement. Cement circulated to surface. Let set 48 hours and tested with 600# for 30 minutes before and after drilling cement plug. No decrease in pump pressure. Resumed drilling
