DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 221 joints 9196' of 7" OD 23 & 26# N-80 & J-55 SS Casing. Set & cemented at 9207' w/380 sacks Trinity slow set 4% Gel cement. Plug at 9124'. Maximum pressure 1000#. Gulf temperature survey in 8 hours found top cement at 7289'.

After waiting over 30 hours tested 7" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 9124' to 9165'.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations, were made to drill ahead.
