DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 10 joints 321.84' of 13-3/8" OD 8 RT 48# SS casing. Set and cemented at 342' w/400 sacks EL Tere Portland cement. Plug at 325'. Maximum pressure 350#. Circulated approximately 15 sacks cement.

After waiting over 24 hours tested 13-3/8" casing w/1000# pressure for 30 min. There was no drop in pressure. Drilled cement plug from 325' to 342' tested cement below casing shoe w/400# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
