4. Treated perforations w/1000 gallons 15% BDA.
5. Ran 3 1/4 jts. (10,437') 2 1/2" tubing & hung @ 10,449'. Seating Nipple @ 10,406'.
6. Ran pump & rods.
7. Recovered load.
8. In 24 hours pumped 23 BO + 129 BW w/7-12' SPM.


