After WOC 2 hrs tested csg to 1000 psi O.K. Drilled out shoe & drilled 11" hole to 324'. Ran & cemented 8 5/8" 24# & 32# J-55 new casing at 324' w/1250 sxz. Circ good while cutg. Did not circ out. WOC 8:30 a.m. 5-31-61. Cut off csg & NU BOP after WOC 6 hrs. Tested csg to 1000 psi O.K. WOC 2 hrs. Drilled out shoe w/7 7/8" bit. Now drilling ahead w/7 7/8" hole at 524'.
