Propose to set plug at top, 4527 feet, of San Andres and cement with 25 sacks; to fill hold from there to base of surface pipe, with another plug in bottom of surface pipe at 295 feet, followed by another 25 sacks of cement and then mud to surface with an additional ten sacks of cement in top of surface pipe as plug and base for four inch marker that will extend six feet above surface.
