Humble Oil & Refining Company C. L. Cain WELL NO. 2 IN K

NE 1/4 SE 1/4 OF SEC. 30, T. 18, R. 39, NMPM., East Hobbs, San Andres POOL  
(40-ACRE SUBDIVISION)  
Lea COUNTY.

FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Pull rods and pump. Install valve on wellhead and shut-in for 48 hours.
2. Run bottom hole pressure.
3. Pull tubing and fire string shot across perforated interval 4450-4462'.  
(Two 100 grain shots)
4. Run tubing with seating nipple, perforation and mud anchor and acidize with 3000 gallons NE acid.
5. Swab well about 8 hours.
6. Shut well in 48 hours.
7. Run bottom hole pressure.
8. Place well on production.
