PROPOSE TO: Set C. I. Plug in 7"OD casing @ 9575' and dump 2 sacks cement on top and plug back to approx. 9565'. Test casing plug. Perforate additional Abo Reef w/2-3/8" jet shots @ approx. the following intervals 8839, 8841, 8875, 8880 and 8882'. Acidize all perfs. 8807-8882' Abo w/approx. 2,000 gals. retarded acid containing NEA and additive. Swab back load and acid water and recomplete as single oilwell in Abo reef formation 8807-8882'.
