Well spudded 1/17/65 at 11:45 A.M. Rigged up combination rig and rotary drilled 11" hole to depth of 1324'. Ran 34 joints 8-5/8" 20# surface casing in hole and set a t 1324' with 300 sx cement, 50-50 po mix w/6% gel and w/2% HA-5. Total pipe in hole 1315'. Cement was circulated to surface. Changed over to cable tools. Waited on cement 18 hours. Ran bailer and bailed well dry. Waited one hour and reran bailer with no show of water for the one hour test period. Drilling ahead with cable tools making 8" hole

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
