T.D. 4350' Anhydrite & Dolomite. Waiting on a completion unit. MIRU a completion unit with a reverse unit and DO the surface plug @ 0 - 55' and the plug @ 323 - 423' and DO in the old hole to 745' and drilled out of the old hole. Drilled a new hole from 745' to 1094'. POOH to 745', fanned bit and attempted to re-enter the old hole from 745' to 1094' with no success. RD completion unit w/reverse unit. MIRU a rotary and reamed a 7-7/8" hole from 373'-1094' and drilled a new 7-7/8" hole from 1094' to a T.D. of 4352' in Anhydrite & Dolomite. Ran and set 106 jts. (4352.24') of 5-1/2" OD 14# casing @ 4352' and cemented w/1200 sacks of Lite w/15# salt & 0.25# Flocele/sack + 200 sacks of Class C + 2% CaCl₂ + 125 sacks of Class C cement. PD @ 1200 CST on 12-27-87. Circulated 300 sacks of cement to the surface. PU BOP, set slips, CO casing and ND BOP.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
