3-27-91. RUPU. TOOH with rods. Unseat pump. TOH. Release RBP @ 7900'. Move down to 8583'. Set RBP and tested to 2000#, OK. TOOH with packer. Perforated 7503-7962' w/21 - .41" holes as follows: 7503-14' (7 holes) 7534-46' (5 holes) and 7946-62' (9 holes). TIH w/RBP and set 8032', pull packer to 7900'. Set packer. Acidized perfs 7946-62' w/1500 gals 10% NEFE acid + 15 ball sealers.

3-30-91. Frac'd perfs 7946-62' (via 2-7/8" tubing) with 12500 gals 40# crosslink gel + 30500# 20/40 Ottawa sand.

3-31-91. Released packer and RBP and TOH. TIH with mud anchor, perf sub, seating nipple at 7769', 92 joints tubing, tubing anchor catcher, 143 joints tubing, set anchor. TIH with pump and rods. Return well to production.

structions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
