On 4/25/00 106 joints of 5½" 17 lb/ft casing was run to 4694' RKB. The casing was cemented with 350 sxs of 35/65 Pozmix followed by 450 sxs of 50/50 Class "H" Pozmix with 6 lb salt/sx and 1/2 of 1% friction reducer. Casing was pressure tested to 2500 PSI for 30 minutes prior to checking flowback.
