Plans have been made to clean out to TD at 4940'. Drill deeper with 3-7/8" bit to 5020'. Frac treat open hole with 5000 gallons of gelled water containing 1/2 to 2# SPG. Flush with 20 barrels of gelled water. Run tubing, rods and pump and return well to production. Will convert to water injection at a later date.
