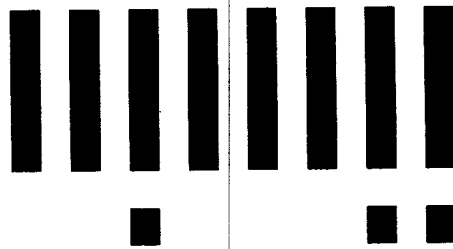

Ran short string of 1-1/4" plastic coated tubing. Set long string in compression with 8000#, short string in compression with 8500#. Closed well in pending start of water injection.
