Plan to pull rods, pump and tubing. Set cast iron cement retainer at 3765'. Squeeze OH 3785' to 3795' with 50 sacks regular cement. Run string shot of 100 and 300 grains per foot across perfs. from 3730' to 3745'. Acidize perfs. with 500 gals. 15% Unisel acid. Swab test. Squeeze with 55 gals. Surfle H-35 and with 5 gals. Surfle S-32 mixed in 50 bbls. fresh water. Displace with 50 bbls. fresh water. Rerun production equipment and resume production.
