12 1/2" 40# 8-thd. New lapweld casing was set in this well at 202' and cemented by the Halliburton Method with 200 sacks.

Casing was drilled out and the hole was then bailed to bottom and allowed to stand undisturbed for one hour. The bailer was then run to bottom to determine if any water had accumulated. No water had accumulated so the drilling was then resumed.
