On February 2, 1954 washed casing perforations from 5718-5732' w/100 gals 15% NE acid, and injected 100 gals 15% NE acid into formation. Avg inj rate 25 gpm, Inj time 4 min, TP-1400-1750# CP-1200-1350#. Flushed w/22 bbls oil.
