DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On July 26, 1948 at 1:30 A.M., 30 hours had elapsed since running 3138' of 5 1/8" new casing in subject well and cementing with 1000 sacks to be used as oil string. At this time casing shut off was tested as follows: A pressure of 1000# was built up and held for 30 minutes, testing OK. Cement plug was drilled and a pressure of 1000# was again built up and held for 30 minutes. This test, too, was OK. Drilling operations were resumed.
