### DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Guiberson Spiral Tubing Packer was run and set at 4075' 5" the water being shut off. Well was cased down 1000 ft. when started flowing 10% out oil, at 6 A.M. 8/12/33 was flowing 10% oil through 18/64 choke with tubing pressure of 100 and no casing pressure. At 8 P.M. 8/12/33 well was flowing pipe line oil through 18/64 choke, no casing pressure, and tubing pressure of 4200 averaging 100 barrels per hour.
