Pulled rods and tubing and tested 6-5/8" OD casing. Set packer @ 2256' and pressured up on 6-5/8" OD casing and could pump into casing @ the rate of 1 B.P.M. with 700#. Leak in 6-5/8" OD casing is above bottom of 8-5/8" casing cut, pulled repaired, re-ran 6-5/8" OD casing and set with casing bowl. Tested 6-5/8" OD casing w/2000# - Held OK.

Reran rods and tubing and put well to pumping.
