or pipe. Cemented with 4 yards and 135x Redi Mix. MIKU Cactus Rig No. 67 and began
continuous drilling operations 12-11-85. Drilled with a 12 1/4" bit to a TD of 1592'.
Ran 8 5/8" 24# K-55 casing and set at 1592'. Cemented with 1050 sx class C cement
w/17% CaCl₂. Bumped plug and circulated 3185x. WOC 18 hrs. Pressure tested casing
1200 psi for 30 mins - ok. Reduced bit to 7 7/8" and resumed drilling.
