It is requested that the temporary abandonment approval for this well be renewed for another year based on the last successful casing integrity test in 8/4/94.

Sand consolidation remedial work is being performed on another well in this pool. If this work is successful, it may be attempted on Warren Unit No. 6 so it can be returned to production in the Warren McKee Pool. This wellbore should be retained in light of this potential remedial work to return it to production.
