FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to return well to production, it is proposed to plug back and acid treat as follows:

1. Pull tubing. Run steel line measurement, if warranted clean out with sand pump.
2. Run Gamma Ray Neutron survey. Plug back with Hydromite to approximately 3800'.
3. Run tubing with formation packer at approximately 3744'. Treat formation below packer with 3000 gallons 15% NE acid. Swab and test.
4. Pull tubing and packer. Run 2-3/8" tubing with packer and return well to production.
