
Dear Sirs:

The subject well was completed on 10-15-55 for an initial daily potential of 139 barrels of oil, flowing thru 48/64" choke with 15.8 MCF gas per day, and a COR of 259. It received an allowable of 38 barrels of oil per day for the month of December, 1955, effective December 1, 1955.

Subsequent to completion the well has gone to 100% water and is now shut-in. Remedial work is planned in the future to return this well to production, but at present no pipe line connections will be made either for oil or gas production.

Cancellation of the allowable and relief from securing a no-flare order is respectfully requested until such time as the well is returned to production.
