DETAILS OF WORK

It is our intention to drill a well with rotary tools at the above location to a total depth of approximately 3070'. All casing points will be cemented in accordance with approved methods of the U. S. Geological Survey and any other requirements will be complied with.

It is planned to use the following casing pattern: 20 3/4" casing to be set at approximately 250' and cemented with 250 sacks. Cement to be circulated to surface. 7 5/8" casing to be set at approximately 3100' and cemented with approximately 1100 sacks or sufficient cement to protect the salt section as determined by caliper survey. 5 1/2" casing to be set at approximately 3070' and cemented with approximately 700 sacks as determined by caliper survey. 5 1/2" casing to be perforated opposite pay section.

Approval to produce this well upon completion is also requested.
