DETAILS OF WORK

It is my intention to drill a well at the above location to an approximate depth of 5150' to attempt a completion in the Delaware Sand Horizon. All casing points will be cemented in accordance with approved methods of the USGS, and any special requirements will be complied with.

It is planned to use the following casing pattern: 11" hole, 7 5/8" casing to be set at approximately 400' and cemented with 200 sacks. Cement is to circulate. 6 3/4" hole, 4 1/2" casing to be set at 5150' and cemented with 200 sacks. Cement is to return to 3800'.

Permission is requested to produce the well upon completion.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

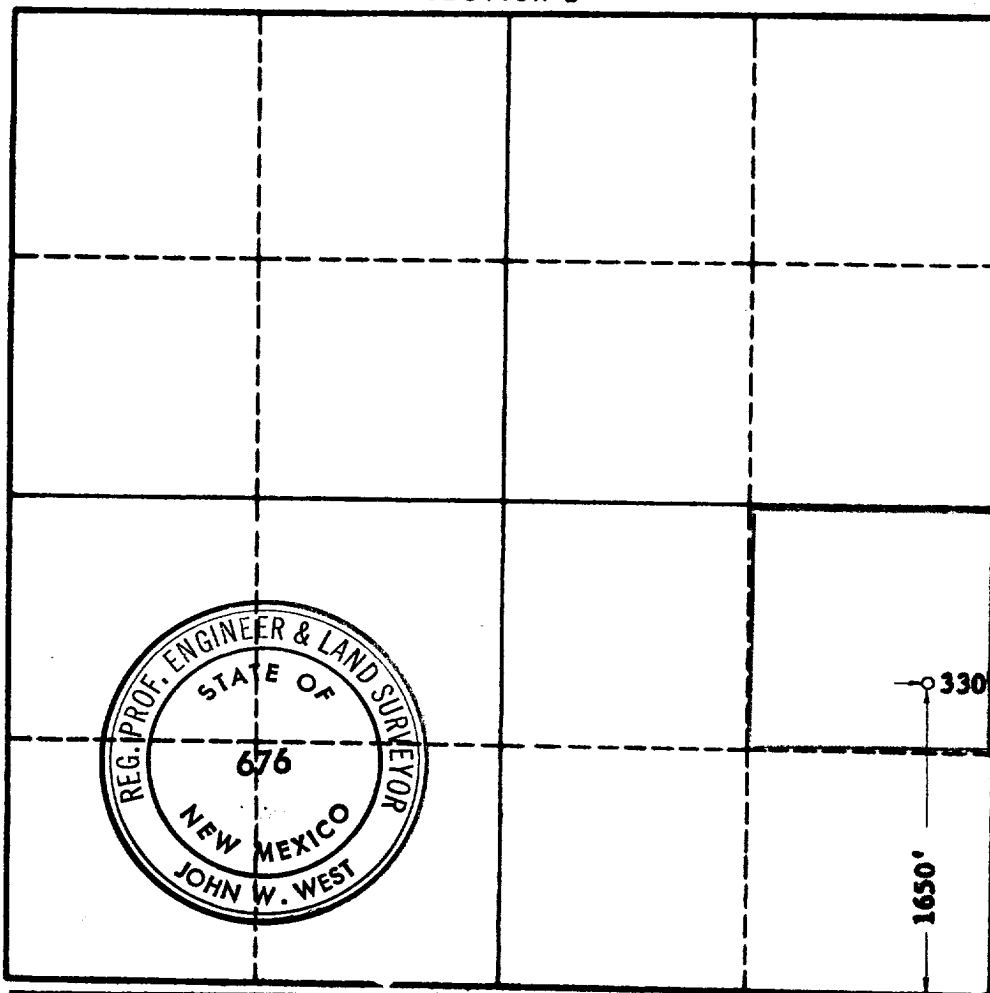
