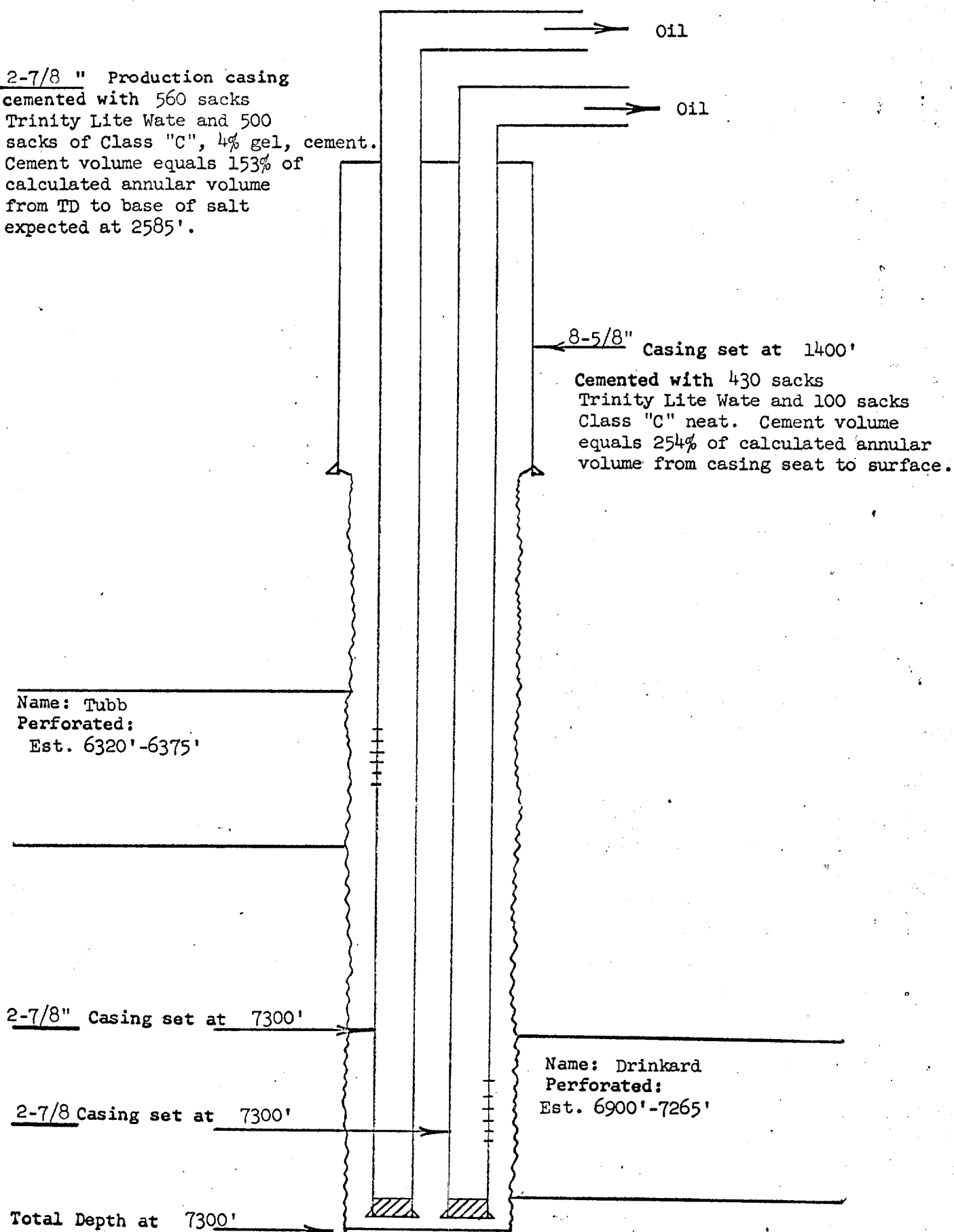

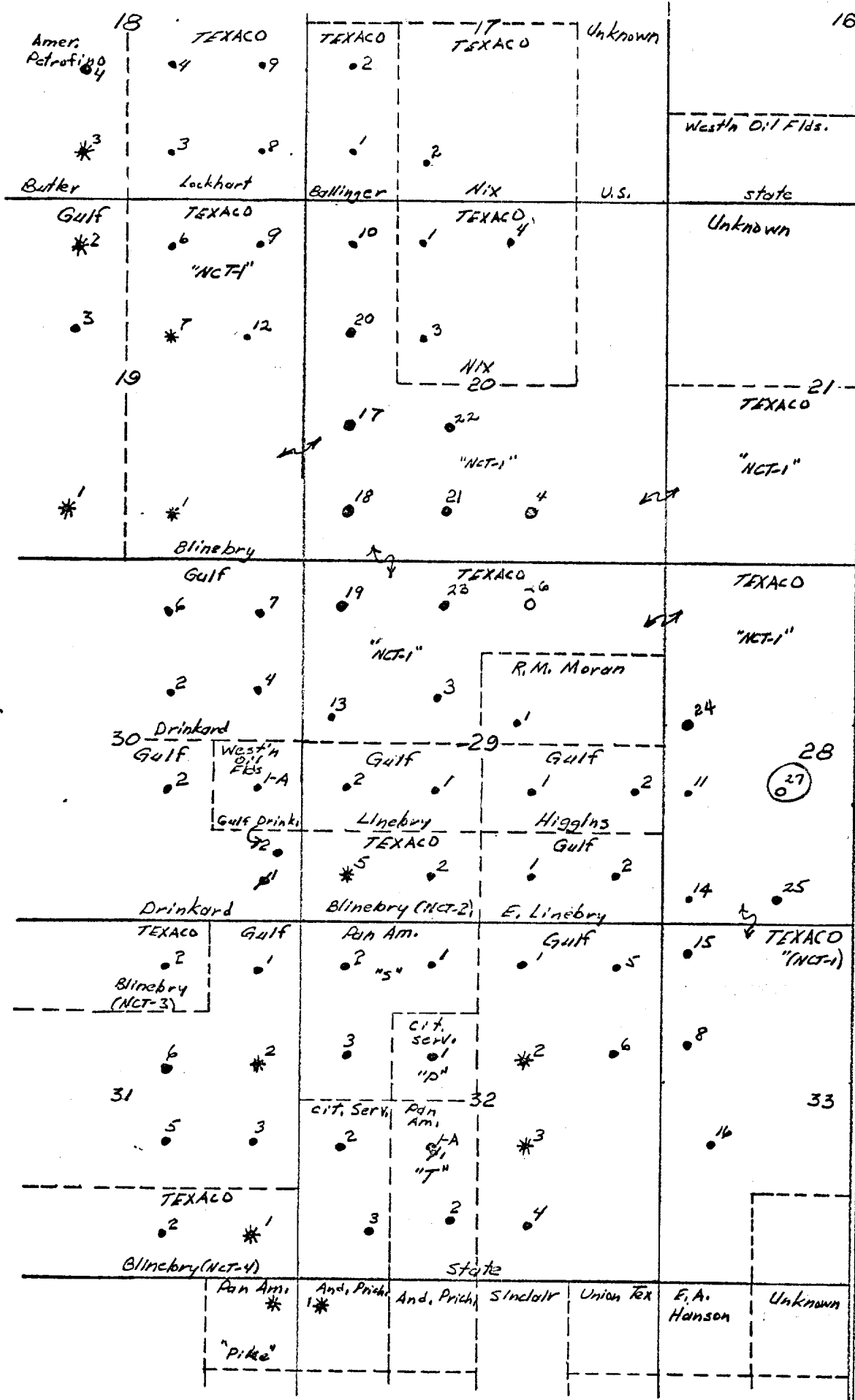
2-7/8 " Production casing
