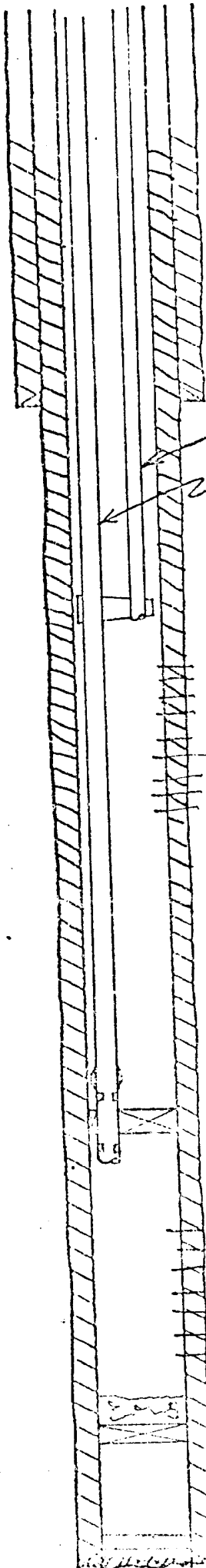
ANDREWS STRICT
