3/19/95: Spud. Drld a 17 1/2" hole to 645'. Ran 14 jts 13 3/*' 48# H-40 csg and set @ 645'. Used four centralizers. Cmted w/lead: 400 sxs 'C' + 4% Bentonite + 2% CaCl2, tail w/200 sxs 'C' + 2% CaCl2 + .25% flocele. WOC 17.75 hrs.

Drld a 12 1/4" hole to 4683'. Ran 8 5/8" 28#/32# K-55 BTC/LTC and set @ 4683'. Used 11 centralizers. Cmted in 2 stages: 1st stage: Lead w/450 sxs 'C' Lite + 9 pps salt + 1 pps econolite + 5 pps gilsonite + 1/4 pps flocele, tail w/250 sxs 'C' + 2 % CaCl2. Circ. 65 sxs to pit. 2nd stage: Lead w/890 sxs 'C' + 9 pps salt + 1/4 pps flocele, tail w/200 sxs 'C' + 2% CaCl2. Circ. 135 sxs to pit. WOC 21.25 hrs.

Drld a 7 7/8" hole to 10,215'. Ran 232 jts of 5 1/2" 17# K-55/N-80 LTC csg and set @ 10,215'. Used twenty centralizers. Cmted in 2 stages: 1st stage: Cmt w/870 sxs 'H' 50/50 Poz + 2% Bentonite + .6% Halad-9 + 3 pps KCL + .25 pps flocele. 2nd stage: Lead w/500 sxs 'H' Lite + 6% Bentonite + .4% Halad-9, tail w/100 sxs 'H' neat. TOC @ 4800'. DV Tool @ 6502'. WOC four days.
