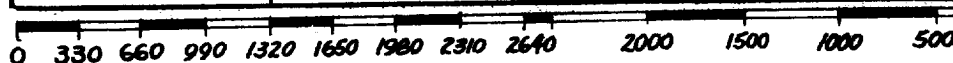

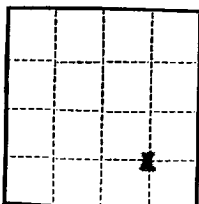

**Objective Sand: Delaware zone @ 5,500'.**

#### Proposed Program:

1. Use rotary tools from surface to total depth. Set  $5\frac{1}{8}$ " 32# casing at 400' and circulate cement to surface.
2. Core 100' of Delaware sand and drillstem test Delaware formation.
3. Set  $4\frac{1}{2}$ " 9.5# & 11.6# casing through Delaware pay zone and cement with 200 sacks cement.
4. Run radioactivity logs and perforate pay zone.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
