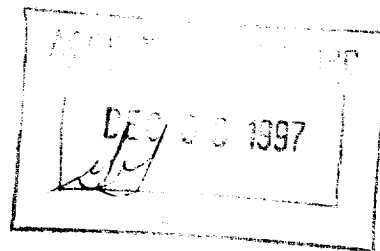

It is proposed to temorarily abandon this well. Time is needed to evaluate the failure of recent fracture stimulation to return this well to economic production.

The following procedure will be used:

1. RU well service unit and pull rods. RU BOP's and pull tubing
2. PU RBP and set RBP at 2800'. POOH Laying down tubulars.
3. Fill hole with inhibited fluid and test to 500 psig for the BLM
