Ran 11 Jts (337') 9-5/8" OD 32# Gr J-55 SS casing. Set and cemented at 350' with 300 sacks regular Heat cement. Plug at 320'. Maximum pressure 200#. Circulated approximately 12 sacks cement. Job complete 3:45AM 9-10-54.

After waiting over 24 hours, tested 9-5/8" casing with 1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 320' to 350'. Tested below casing shoe with 600# for 30 minutes. There was no drop in pressure.
