DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Put in 5' cement plug in bottom, mudded to base of salt, then placed 5' cement plug. Then mudded to top of salt and placed 5' cement plug; mudded to top and capped with cement. Then a regulation marker was cemented in bottom of cellar, which consisted of 4" pipe cemented in bottom of cellar and extending 4' above surface of ground.

251' of 9 5/8" casing.

1060' of 7" casing;
414' of 5 1/2" (liner);
946' of 9 5/8" casing;
436' of 13" casing.
