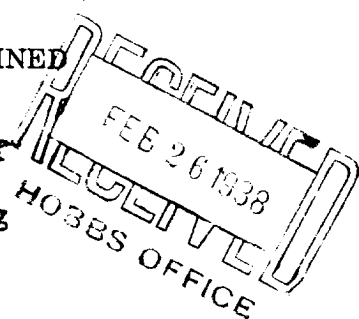

10-3/4" surface casing was tested for water shut-off at a depth of 346 feet. Hole was bailed dry after drilling plug, and remained so for one hour. Casing stood cemented for 36 hours before drilling plug.
