A recent packer leakage test showed communication on this dually completed well. In conjunction with repair work, we propose to perforate the Upper Blinbry at 5024-40, 5049-54 & 5090-98' w/2 JSPF and frac w/25,000 gallons of lease crude containing 30,000# 20/40 sand. This will be an attempt to raise the Blinbry zone from its present producing capacity of 26 BOPD to a full allowable well.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
