The Commission is concerned that this assistance may be used for the purpose of suppressing the legitimate rights and freedoms of the people of the Philippines, and for the purpose of maintaining the authoritarian rule of the Government of the Philippines. The Commission is therefore requesting the Government of the United States of America to provide information regarding the nature and extent of the military assistance provided to the Government of the Republic of the Philippines, and to ensure that such assistance is not used for the purpose of suppressing the legitimate rights and freedoms of the people of the Philippines.
