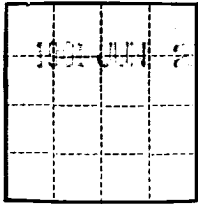

DETAILS OF WORK

We propose to drill with rotary tools to the Seven Rivers-Queen formation at about 3,500'. Set 8 5/8" casing at 330' with cement circulated. If productive, set 5 1/2" casing to total depth and cement with 250 sacks which gives a calculated fillup of 1,691'.
