The New Mexico Oil Conservation Division (OCD) has completed a review of ARCO Pipe Line Company's (ARCO) October 1996 "REMEDIATION WORKPLAN, MONUMENT RELEASE SITE, MONUMENT, NM" which was received by the OCD Santa Fe Office on October 28, 1996. This document contains ARCO's plan for remediation of soils related to a spill of crude oil located in the SW/4, Sec 02, T20S, R36E, NMPM, Lea County, New Mexico.


The above work plan is approved with the following conditions:

1. ARCO will submit a final remedial action report to the OCD within 30 days of completion of the remedial actions. The final report will include the results of the vertical extent of contamination, soil remediation levels achieved, the laboratory analyses and associated quality assurance/quality control data and the disposition of the remediated soils.
2. ARCO will submit the report to the OCD Santa Fe Office with a copy provided to the OCD Hobbs District Office.

Please be advised that OCD approval does not relieve ARCO of liability if the remedial work plan fails to adequately determine the extent of or remediate contaminants at the site. In addition, OCD approval does not relieve ARCO of responsibility for compliance with any other federal, state or local laws and/or regulations.
