The New Mexico Oil Conservation Division (OCD) has completed a review of Texas-New Mexico Pipe Line Company's (TNMPLC) December 10, 1998 "CLOSURE REPORT, MONUMENT SITE 4, MONUMENT, NEW MEXICO, JOB NO. 610057" which was submitted on behalf of TNMPLC by their consultant KEI. These documents request closure of remedial actions resulting from a crude oil pipeline spill at TNMPLC's Monument No. 4 site.

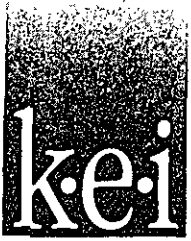

Dear Mr. Savoie:

The New Mexico Oil Conservation Division (OCD) has reviewed Texas-New Mexico Pipe Line Company's (TNMPLC) September 19, 1997 "COMPREHENSIVE ASSESSMENT REPORT, TEXAS - NEW MEXICO PIPELINE COMPANY MONUMENT SITE NO. 4, LEA COUNTY, NEW MEXICO" which was received by the OCD on October 3, 1998.

This document contains the results of TNMPLC's investigation of the extent of soil contamination resulting from a crude oil pipeline spill at TNMPLC's Monument No. 4 Site located in Unit F, Section 36, Township 19 South, Range 36 East, Lea County, New Mexico. The document also contains recommendations for remediation of remaining soil areas with elevated levels of petroleum contaminants.

The OCD approves of the recommendations contained in the above referenced document with the following conditions:

1. TNMPLC will submit a final remediation report upon completion of the soil excavation and landfarming remedial actions. The report will be submitted to the OCD Santa Fe Office for approval with a copy provided to the OCD Hobbs District Office.
2. TNMPLC will notify the OCD at least 48 hours in advance of scheduled activities such that the OCD has the opportunity to witness the events and split samples.
