The proposed surface and bottom hole locations and first and last take points are as follows:

- 1. SHL: 2437' FSL and 1662' FWL of Section 11, T26S-R25E
- 2. FTP: 2550' FNL and 2336' FWL of Section 11, T26S-R25E
- 3. LTP: 100' FEL and 2350' FWL of Section 2, T26S-R25E
- 4. BHL: 10' FNL and 2325' FWL of Section 2, T26S-R25E

It is Titus's responsibility as a prudent operator to maximize the recovery of oil and gas reserves left in the ground. Approval of the unorthodox completed interval will allow Titus to use its preferred well spacing plan for horizontal wells in this area and thereby maximize recovery and prevent waste.




