**Re: Application of Ameredev Operating, LLC to amend Administrative Order CTB-944 to add certain wells and spacing units, and to authorize lease commingling, at the Amen Corner State Com Central Tank Battery located in the S/2 SW/4 (Units M & N) of Section 22, Township 26 South, Range 36 East, NMPM, Lea County, New Mexico.**

Dear Ms. Sandoval:

Under Administrative Order CTB-944, attached as **Exhibit 1**, the Division approved Ameredev Operating, LLC's (OGRID No. 372224) ("Ameredev"), request for lease commingling, off-lease storage, off-lease measurement, and off-lease marketing at the **Amen Corner State Com Central Tank Battery** of production from the WC-025 G-09 S263619C: Wolfcamp (98234) pool from *all existing and future wells drilled in the following "spacing units"*:

- (a) The 640-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the E/2 W/2 and the W/2 E/2 of Sections 15 and 22. The spacing unit is currently dedicated to the **Magnolia State Com 26 36 22 #125H well** (API No. 30-025-45897); and
- (b) The 320-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the W/2 W/2 of Sections 16 and 21. The spacing unit is currently dedicated to the **Camellia Fed Com 26 36 21 #121H well** (API No. 30-025-44810); and
- (c) Pursuant to 19.15.12.10.C(4)(g) NMAC, all future spacing units connected to this central tank battery with notice provided only to the interest owners within the future spacing units.

Pursuant to 19.15.12.7 NMAC, Ameredev seeks to amend the terms of Administrative Order CTB-944 to allow for lease commingling between all production from *all existing and future infill wells* drilled in the following spacing units:

- (a) The 233.75-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the W/2 W/2 of Sections 28 and 33. The spacing unit is currently dedicated to the **Azalea 26 36 28 State #111H well** (API No. 30-025-44104), the **Azalea 26 36 28 State #121Y well** (API No. 30-025-44229);
- (b) The 160-acre, more or less, spacing unit in the Jal; Wolfcamp (33813) pool underlying the W/2 W/2 of Section 19. The spacing unit is currently dedicated to the **Prizehog BWZ State Com #1H well** (API No. 30-025-42774);
- (c) The 160-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the E/2 E/2 of Section 19. The spacing unit is currently dedicated to the **Prizehog BWZ State Com #2H well** (API No. 30-025-44111);
- (d) The 160-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the E/2 W/2 of Section 20. The spacing unit is currently dedicated to the **Wildhog BWX State Com #1H well** (API No. 30-025-42733); and
- (e) The 160-acre, more or less, spacing unit in the WC-025 G-09 S263619C: Wolfcamp (98234) pool underlying the E/2 E/2 of Section 20. The spacing unit is currently dedicated to the **Wildhog BWX State Com #2H well** (API No. 30-025-44112).

Oil and gas production from these spacing units will be commingled and sold at the **Amen Corner State Com Central Tank Battery** located in the S/2 SW/4 (Units M & N) of Section 22. Prior to commingling, gas production from each spacing unit will be separately metered using individual test separators with calibrated orifice meters that are manufactured to AGA specifications. Oil production from each spacing unit will also be separately metered using turbine meters.

**Exhibit 2** is a land plat showing Ameredev's current development plan for these wells, the corresponding lease names and numbers, the pad sites, and the common surface facilities located in the S/2 SW/4 (Units M & N) of Section 22.

**Exhibit 3** is a C-102 for each of the wells currently permitted or drilled within the existing spacing units, together with available production reports for each well.

**ORDER**

The Director of the New Mexico Oil Conservation Division (“OCD”), having considered the application, issues the following Order.

**FINDINGS OF FACT**

1. Ameredev Operating, LLC (“Applicant”) submitted a complete application to surface commingle and off-lease measure the oil and gas production (“Application”) from the pools, leases, and wells identified in Exhibit A.
2. To the extent that ownership is identical, Applicant submitted a certification by a licensed attorney or qualified petroleum landman that the ownership in the pools, leases, and wells to be commingled is identical as defined in 19.15.12.7(B) NMAC.
3. Applicant proposed a method to allocate the oil and gas production to the pools, leases, and wells to be commingled.
4. To the extent that ownership is diverse, Applicant provided notice of the Application to all persons owning an interest in the oil and gas production to be commingled, including the owners of royalty and overriding royalty interests, regardless whether they have a right or option to take their interests in kind, and those persons either submitted a written waiver or did not file an objection to the Application.
5. Applicant provided notice of the Application to the Bureau of Land Management (“BLM”) or New Mexico State Land Office (“NMSLO”), as applicable.
6. Applicant in the notice for the Application stated that it sought authorization to add additional pools, leases, and wells and identified the parameters to make such additions.

**CONCLUSIONS OF LAW**

7. OCD has jurisdiction to issue this Order pursuant to the Oil and Gas Act, NMSA 1978, §§ 70-2-6, 70-2-11, 70-2-12, 70-2-16, and 70-2-17, and 19.15.12 NMAC.
8. To the extent that ownership is diverse, Applicant satisfied the notice requirements for the Application in accordance with 19.15.12.10(A)(2), (C)(4)(c), and (C)(4)(e) NMAC.
9. Applicant’s proposed method of allocation, as modified herein, complies with 19.15.12.10(B)(1) or (C)(1) NMAC, as applicable.

10. Commingling involving state, federal, or tribal leases shall not commence until approved by the BLM or NMSLO, as applicable, in accordance with 19.15.12.10(B)(3) and (C)(4)(h) NMAC.
11. Subsequent additions of pools, leases, and wells within Applicant's defined parameters, as modified herein, will not, in reasonable probability, reduce the commingled production's value or otherwise adversely affect the interest owners in the production to be added. Applicant satisfied the notice requirements for subsequent additions of pools, leases, and wells in the notice for the Application, in accordance with 19.15.12.10(C)(4)(g) NMAC.
12. By granting the Application with the conditions specified below, this Order prevents waste and protects correlative rights, public health, and the environment.

### **ORDER**

1. Effective March 30, 2020, Applicant is authorized to surface commingle and off-lease measure oil and gas production from the pools, leases, and wells identified in Exhibit A.
2. The oil and gas production from each well shall be separated and metered prior to commingling.
3. Applicant shall measure the commingled oil at the central tank battery described in Exhibit A in accordance with 19.15.18.15 NMAC or 19.15.23.8 NMAC.
4. Applicant shall measure the commingled gas at the central delivery point described in Exhibit A in accordance with 19.15.19.9 NMAC, provided however that if the gas is flared, regardless whether OCD has granted an exception pursuant to 19.15.18.12(B) NMAC, Applicant shall report the gas in accordance with 19.15.18.12(F) NMAC.
5. Applicant shall calibrate the meters used to measure or allocate oil and gas production in accordance with 19.15.12.10(C)(2) NMAC.
6. Applicant may submit an application to amend this Order to add pools, leases, and subsequently drilled wells with spacing units adjacent to or within the tracts commingled by this Order by submitting a Form C-107-B via the OCD Fee Portal and providing notice of the application to all owners of interest in the production to be added.
7. Applicant shall not commence commingling involving state, federal, or tribal leases until approved by the BLM or NMSLO, as applicable.
8. OCD retains jurisdiction and reserves the right to modify or revoke this Order if it determines that the Application did not accurately describe any action affecting or related to the commingling of oil and gas production, or as deemed necessary to prevent waste or protect correlative rights, public health, or the environment

Ameredev Operating, LLC, OGRID: 372224, requests to commingle current oil and gas production from the Camellia Fed Com 26 36 21, Magnolia State Com 26 36 22, Azalea 26 36 28 State, Wildhog BWX State Com, and Prizehog BWZ State Com leases. All wells will go through individual three phase separators and each stream (oil, water, gas) will be measured as it exits the three phase separator. Oil will be measured at the three phase separator with a Coriolis meter, gas will be measured with an orifice meter, and water will be measured with a mag meter.

Commingling will happen after the three phase separator. The gas stream will flow into a common line and flow into an additional two phase separator to remove any excess water. The gas will then go into a sales meter before going into a gas gathering pipeline. The oil and water from the Azalea 26 36 28 State, Wildhog BWX State Com, and Prizehog BWZ State Com leases will be commingled back together and sent down a flowline to the Amen Corner CTB. At the Amen Corner CTB, the liquids will go through a 3 phase separator and will be broken back into oil and water streams. The oil will flow into a common line after the three phase separator and will flow into a heater treater and a vapor recovery tower to remove any remaining water and gas in the oil stream. The oil will then go to lined oil tanks to be either trucked off or piped into our crude gathering pipelines. The water will be commingled after the three phase separator into a common line that will flow into a gun barrel before it is pumped into our water pipeline system. The gas will be allocated against a main sales meter and the oil will be allocated against the CTB LACT meter. All meters will be calibrated according to manufacturer's recommendations.

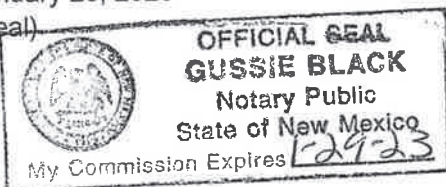

**ORDER**

The Director of the New Mexico Oil Conservation Division (“OCD”), having considered the application and the recommendation of the OCD Engineering Bureau, issues the following Order.

**FINDINGS OF FACT**

1. Ameredev Operating, LLC (“Applicant”) submitted a complete application to surface commingle and off-lease measure the oil and gas production ("Application") from the pools, leases, and wells identified in Exhibit A.
2. Applicant proposed a method to allocate the oil and gas production to the pools, leases, and wells to be commingled.
3. To the extent that ownership is identical, Applicant submitted a certification by a licensed attorney or qualified petroleum landman that the ownership in the pools, leases, and wells to be commingled is identical as defined in 19.15.12.7(B) NMAC.
4. To the extent that ownership is diverse, Applicant provided notice of the Application to all persons owning an interest in the oil and gas production to be commingled, including the owners of royalty and overriding royalty interests, regardless of whether they have a right or option to take their interests in kind, and those persons either submitted a written waiver or did not file an objection to the Application.
5. Applicant provided notice of the Application to the Bureau of Land Management (“BLM”) or New Mexico State Land Office (“NMSLO”), as applicable.
6. Applicant in the notice for the Application stated that it sought authorization to add additional pools, leases, and wells and identified the parameters to make such additions.
7. Applicant stated that it sought authorization to surface commingle and off-lease measure, as applicable, oil and gas production from wells which have not yet been approved to be drilled, but will produce from a pool and lease identified in Exhibit A.

**CONCLUSIONS OF LAW**

8. OCD has jurisdiction to issue this Order pursuant to the Oil and Gas Act, NMSA 1978, §§ 70-2-6, 70-2-11, 70-2-12, 70-2-16, and 70-2-17, and 19.15.12 NMAC.
9. Applicant satisfied the notice requirements for the Application in accordance with 19.15.12.10(A)(2), (C)(4)(c), and (C)(4)(e) NMAC, as applicable.



10. Applicant's proposed method of allocation, as modified herein, complies with 19.15.12.10(B)(1) or (C)(1) NMAC, as applicable.
11. Commingling of oil and gas production from state, federal, or tribal leases shall not commence until approved by the BLM or NMSLO, as applicable, in accordance with 19.15.12.10(B)(3) and (C)(4)(h) NMAC.
12. Applicant satisfied the notice requirements for the subsequent addition of pools, leases, and wells in the notice for the Application, in accordance with 19.15.12.10(C)(4)(g) NMAC. Subsequent additions of pools, leases, and wells within Applicant's defined parameters, as modified herein, will not, in reasonable probability, reduce the commingled production's value or otherwise adversely affect the interest owners in the production to be added.
13. By granting the Application with the conditions specified below, this Order prevents waste and protects correlative rights, public health, and the environment.

### **ORDER**

1. Applicant is authorized to surface commingle and off-lease measure oil and gas production from the pools, leases, and wells identified in Exhibit A.

Applicant is authorized to surface commingle and off-lease measure, as applicable, oil and gas production from wells not included in Exhibit A but that produce from a pool and lease identified in Exhibit A.

2. This Order supersedes Order CTB-944.
3. The allocation of oil and gas production to wells not included in Exhibit A but that produce from a pool and lease identified in Exhibit A shall be determined in the same manner as to wells identified in Exhibit A that produce from that pool and lease, provided that if more than one allocation method is being used or if there are no wells identified in Exhibit A that produce from the pool and lease, then allocation of oil and gas production to each well not included in Exhibit A shall be determined by OCD prior to commingling production from it with the production from another well.
4. The oil and gas production for each well identified in Exhibit A shall be separated and metered prior to commingling.
5. Applicant shall measure the commingled oil at a central tank battery described in Exhibit A in accordance with 19.15.18.15 NMAC or 19.15.23.8 NMAC.
6. Applicant shall measure the commingled gas at a central delivery point or central tank battery described in Exhibit A in accordance with 19.15.19.9 NMAC, provided however that if the gas is flared, and regardless of whether OCD has granted an exception pursuant to 19.15.18.12(B) NMAC, Applicant shall report the gas in accordance with 19.15.18.12(F) NMAC.
7. Applicant shall calibrate the meters used to measure or allocate oil and gas production in accordance with 19.15.12.10(C)(2) NMAC.

8. If the commingling of oil and gas production from any pool, lease, or well reduces the value of the commingled oil and gas production to less than if it had remained segregated, no later than sixty (60) days after the decrease in value has occurred Applicant shall submit a new surface commingling application to OCD to amend this Order to remove the pool, lease, or well whose oil and gas production caused the decrease in value. If Applicant fails to submit a new application, this Order shall terminate on the following day, and if OCD denies the application, this Order shall terminate on the date of such action.
9. Applicant may submit an application to amend this Order to add pools, leases, and subsequently drilled wells with spacing units adjacent to or within the tracts commingled by this Order by submitting a Form C-107-B via the OCD Fee Portal in accordance with 19.15.12.10(C)(4)(g) NMAC.
10. If a well is not included in Exhibit A but produces from a pool or lease identified in Exhibit A, then Applicant shall submit Forms C-102 and C-103 to the OCD Engineering Bureau after the well has been approved to be drilled and prior to off-lease measuring or commingling oil or gas production from it with the production from another well. The Form C-103 shall reference this Order and identify the well and proposed method to determine the allocation of oil and gas production to it.
11. Applicant shall not commence commingling oil or gas production from state, federal, or tribal leases until approved by the BLM or NMSLO, as applicable.
12. OCD retains jurisdiction and reserves the right to modify or revoke this Order as it deems necessary to prevent waste or protect correlative rights, public health, or the environment.
