EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Heartthrob 17 State Com #205H well** (API No. 30-025-47141) to be completed within the Triple X; Bone Spring, West Pool [96674], underlying the E/2 Sections 17 and 14, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico.

This well is to be drilled and completed at a <u>surface location</u> 680 feet from the north line and 1,354 feet from the east line (Unit B) of Section 17. The <u>first take point</u> is located 100 feet from the north line and 2,313 feet from the east line (Unit B) of Section 17, and the <u>last take point</u> is located 100 feet from the south line and 2,313 feet from the east line (Unit C) of Section 17.

Since this acreage is governed by the Division's statewide rules, the completed interval for this well will be unorthodox because it is closer than the standard offsets to the western boundary of the spacing unit. Approval of the unorthodox completed interval will allow EOG to use their preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

Exhibit A is a Form C-102, together with an as-drilled plat, showing the completed interval of the proposed **Heartthrob 17 State Com #205H well** encroaches on the spacing unit/tracts to the west in the W/2 of said Section 17.






