Tap Rock Operating, LLC ("Tap Rock") (OGRID No. 372043) seeks administrative approval of an unorthodox well location for its **Cypress 34 Federal #241H Well** (API No. 30-015-47264) to be completed within the Purple Sage; Wolfcamp Pool (98220) underlying the W/2 of Section 34, Township 23 South, Range 29 East, N.M.P.M., Eddy County, New Mexico.

This well will be drilled from a <u>surface location</u> 298 feet from the north line and 226 feet from the west line (Unit D) of Section 34, to a <u>bottom hole location</u> 30 feet from the south line and 331 feet from the west line (Unit M) of Section 34.

The <u>first take point</u> will be located 100 feet from the north line and 331 feet from the west line (Unit D) of Section 34 and the <u>last take point</u> will be 100 feet from the south line and 331 feet from the west line (Unit M) of Section 34.

Pursuant to Division Order R-14262, this acreage is governed by the Special Rules for the Purple Sage; Wolfcamp (Gas) Pool which provide for wells in the Wolfcamp formation in Eddy County to be located no closer than 330 feet to the outer boundary of the spacing unit. The completed interval for the **Cypress 34 Federal #241H Well** will be unorthodox because it is closer than 330 feet to the northern and southern boundaries of the horizontal spacing unit. 



LOCATION & ELEVATION VERIFICATION MAP


