Pursuant to Division Rules 19.15.16.15(C)(6) and 19.15.15.13(C)-(D) NMAC and the applicable rules governing the acreage and well location requirements for the Jabalina; Wolfcamp, Southwest Pool (Pool Code 96776), Titus Oil & Gas Production, LLC ("Titus") requests administrative approval of a non-standard location for the above-referenced well, as described more fully below.

Standard setbacks for the perpendicular portion of a horizontal oil well are 330 feet from the outer boundary of the spacing unit. The above-referenced well, however, will be 195 feet from the western boundary of the spacing unit. The affected tracts will be the W/2 E/2 of Section 29 and Lot 2 and NW/4 NE/4 of Section 32, T26S-R35E, Lea Co., NM. Titus is requesting approval to decrease the setbacks for the horizontal portion of the above-referenced well as indicated below.

The proposed surface and bottom hole locations and first and last take points are as follows:

1. SHL: 558' FSL and 650' FEL of Section 20, T26S-R35E
2. FTP: 100' FNL and 1124' FEL of Section 29, T26S-R35E
3. LTP: 100' FSL and 989' FEL of Section 32, T26S-R35E
4. BHL: 0' FSL and 989' FEL of Section 32, T26S-R35E

It is Titus' responsibility as a prudent operator to maximize the recovery of oil and gas reserves left in the ground. Approval of the unorthodox, completed interval will allow Titus to use its preferred well spacing plan for horizontal wells in this area and thereby maximize recovery and prevent waste.

Attached is the draft C-102 form and plat to assist the Division in its review of Titus's requests. Titus has sent notice to all affected persons on the enclosed spreadsheet by certified mail, return receipt requested, with a copy of this request, the plat, and the draft C-102. The notice also informs the affected persons that, if they object to the aforementioned requests, they must file the objection in writing with the Division within 20 days from the date the Division receives this administrative approval request. I attach a sample of the notice letter and a spreadsheet with the types of interests and names of the affected parties, the location of each parties' interest, the date the letter was sent, and the mail tracking number for the mailings that went out today.

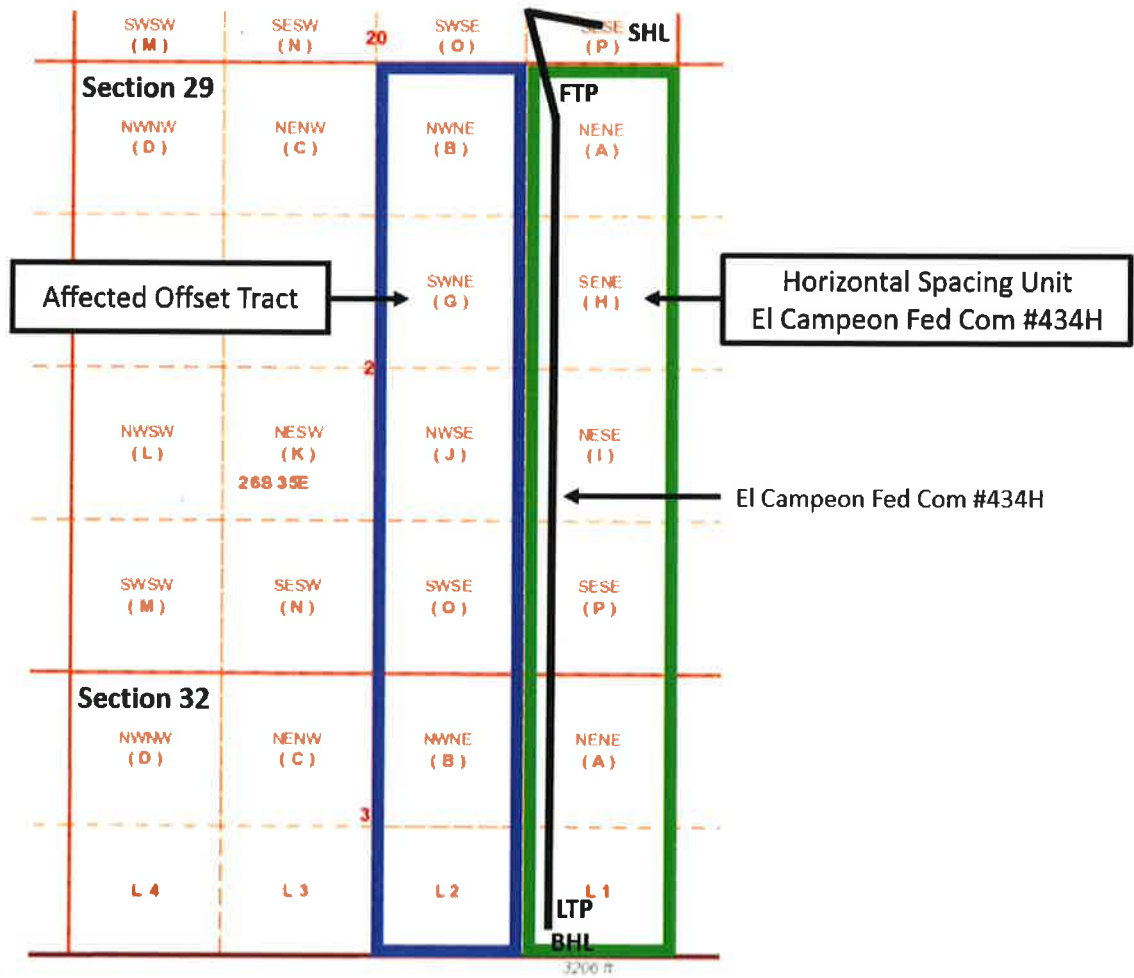


